BOATS: BOAT OWNERSHIP IS BEING DETERMINED FROM THE NC WILDLIFE COMMISSION. LIST ALL BOAT AND BOAT MOTORS. IF YOU HAVE A CURRENT STATE ID NUMBER (NC-) YOU SHOULD RECEIVE BY JAN 5, 1999, A SEPARATE FORM ON WHICH TO LIST AND VERIFY. IF YOU DID NOT RECEIVE A SEPARATE FORM, LIST YOUR BOAT ON THIS FORM.

LICENSED VEHICLES: DO NOT LIST VEHICLES WHICH ARE CURRENTLY LICENSED. THE PROPERTY TAX ON THESE VEHICLES WILL BE BILLED BY THE COUNTY APPROXIMATELY 90 DAYS AFTER THE CURRENT LICENSE IS RENEWED OR APPLICATION IS MADE FOR A NEW LICENSE.

PROPERTY TAX RELIEF FOR ELDERLY AND PERMANENTLY DISABLED G.S. 105-277.1

NORTH CAROLINA EXCLUDES FROM PROPERTY TAXES THE FIRST TWENTY THOUSAND DOLLARS (\$20,000) IN ASSESSED VALUE OF CERTAIN PROPERTY OWNED BY NORTH CAROLINA RESIDENTS AGED 65 OR OLDER OR TOTALLY AND PERMANENTLY DISABLED WHOSE DISPOSABLE INCOME DOES NOT EXCEED FIFTEEN THOUSAND DOLLARS (\$15,000). THE EXCLUSION COVERS REAL PROPERTY (OR A MOBILE HOME) OCCUPIED BY THE OWNER AS HIS OR HER PERMANENT RESIDENCE. DISPOSABLE INCOME INCLUDES ALL MONEYS RECEIVED OTHER THAN GIFTS OR INHERITANCES RECEIVED FROM A SPOUSE, LINEAL ANCESTORS, OR LINEAL DESCENDANTS. IF YOU RECEIVED THIS EXCLUSION LAST YEAR AND YOUR DISPOSABLE INCOME LAST YEAR WAS ABOVE FIFTEEN THOUSAND DOLLARS (\$15,000), YOU MUST NOTIFY THE REVENUE ADMINISTRATOR. IF YOU RECEIVED THE EXCLUSION LAST YEAR BECAUSE YOU WERE TOTALLY AND PERMANENTLY DISABLED AND YOU ARE NO LONGER TOTALLY AND PERMANENTLY DISABLED, YOU MUST NOTIFY THE REVENUE ADMINISTRATOR. IF THE PERSON WHO RECEIVED THE EXCLUSION LAST YEAR WAS DECEASED PRIOR TO JANUARY 1, THE PERSON REQUIRED BY LAW TO LIST THE PROPERTY MUST NOTIFY THE REVENUE ADMINISTRATOR. FAILURE TO MAKE ANY OF THE NOTICES REQUIRED BY THIS PARAGRAPH BEFORE APRIL 15 WILL RESULT IN PENALTIES AND INTEREST. IF YOU DID NOT RECEIVE THE EXCLUSION LAST YEAR, BUT ARE NOW ELIGIBLE, YOU MAY OBTAIN AN APPLICATION FROM THE WAKE COUNTY REVENUE DEPARTMENT. THE COMPLETED FORM MUST BE RETURNED BY APRIL 15, OTHERWISE, YOUR APPLICATION WILL BE DENIED. MAXIMUM DISPOSABLE INCOME OF FIFTEEN THOUSAND DOLLARS (\$15,000) IS JOINT INCOME AND PERTAINS TO BOTH ELDERLY AND PERMANENTLY DISABLED APPLICATIONS.
