Subject: Renewal of Haulers Privilege License for Fiscal Year 2012

Wake County's Solid Waste Ordinance requires every person, firm, and corporation engaged in the collection of garbage, refuse, solid wastes, or recyclables in Wake County to be licensed. **Haulers must renew their annual license by July 31, 2011.**

Steps to **renew** your organization's existing hauler's license:

1. Complete the attached form
2. Issue a check for \$100 licensing fee made payable to Wake County Solid Waste Management Division
3. Return the completed form and check in the pre-addressed envelope

Steps to **apply** for a license (if your company has never been licensed through Wake County):

1. Complete the application online at www.wakegov.com/recycling/haulers
(If you do not have access to the internet, please contact me and I will mail a copy of the application to your place of business)
2. Submit a copy of your company's liability insurance to the address below
3. Remit payment for \$100.00 made payable to Wake County Solid Waste Management Division at the address below:

Once we receive your updated information and payment we will process your application and you will receive your license in the mail. Please allow 4 -6 weeks to process application. At that time you will be in compliance with Wake County's Solid Waste Ordinance and will be permitted to utilize Wake County's solid waste facilities for fiscal year 2012 (July 1, 2011 until June 30, 2012).
