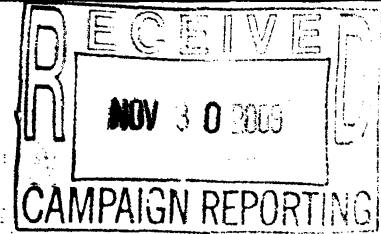

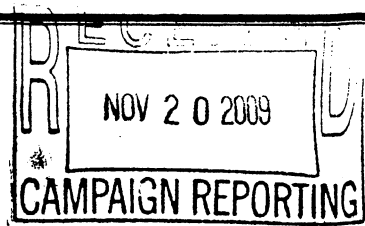

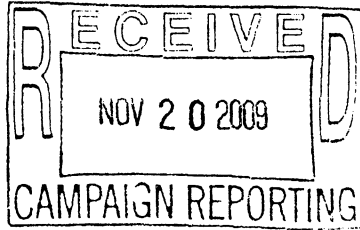

Now that the October and November Elections for 2009 are over, we have been receiving numerous calls from committees on what is due. Many committees are wishing to close or finalize their Campaign Finance Account with this office.

If you are a committee currently filing UNDER the threshold, and you do not desire to disburse all funds nor intend on receiving contributions or making expenditures for a period of time, you may file a *Certification of Inactive Status* form (CRO-3200). During the time the committee is Inactive, disclosure reports are not required. If at some point the Committee intends on receiving contributions or making expenditures, the *Certification to Return to Active Status* (CRO-3300) form should be completed and all subsequent disclosure reports should be filed. If you are a Committee filing OVER the threshold, you have the option of going to an Inactive status, BUT you must submit all required disclosure reports from the date of your last report cut-off date through the date you elect to go to an Inactive Status.

Some committees are choosing to close their committee. If your committee is UNDER the threshold, you may ~~close if your balance is ZERO. If your committee is OVER the threshold and your balance is ZERO, you may~~ submit a *Certification to Close* form (CRO-3400) accompanied by the required Final Disclosure Report. Enclosed you will find the *Certification to Close Committee* (CRO-3400) if you choose this option.

Please understand that neither of the aforementioned options are required. You may choose to maintain an open committee subject to future applicable reporting periods.

SENATE BILL 1014

AN ACT TO STRENGTHEN THE LITTERING LAWS.

The General Assembly of North Carolina enacts:.....

SECTION 7. Article 3 of Chapter 163 of the General Statutes is amended by adding a new section to read:


"§ 163-22.3. State Board of Elections littering notification. At the time an individual files with the State Board of Elections a notice of candidacy pursuant to G.S. 163-106, 163- 112, 163-291, 163-294.2, or 163-323, is certified to the State Board of Elections by a political party executive committee to fill a nomination vacancy pursuant to G.S. 163-114, is certified to the State Board of Elections by a new political party as that party's nominee pursuant to G.S. 163-98, qualifies with the State Board of Elections as an unaffiliated or write-in candidate pursuant to Article 11 of this Chapter, or formally initiates a candidacy with the State Board of Elections pursuant to any statute or local act, the State Board of Elections shall notify the candidate of the provisions concerning campaign signs in G.S. 136-32 and G.S. 14-156, and the rules adopted by the Department of Transportation pursuant to G.S. 136-18."

SECTION 8. Article 4 of Chapter 163 of the General Statutes is amended by adding a new section to read:

"§ 163-33.3. County board of elections littering notification. At the time an individual files with a county board of elections a notice of candidacy pursuant to G.S. 163-106, 163- 112, 163-291, or 163-294.2, is certified to a county board of elections by a political party executive committee to fill a nomination vacancy pursuant to G.S. 163-114, qualifies with a county board of elections as an unaffiliated or write-in candidate pursuant to Article 11 of this Chapter, or formally initiates with a county board of elections a candidacy pursuant to any statute or local act, the county board of elections shall notify the candidate of the provisions concerning campaign signs in G.S. 136-32 and G.S. 14-156 and the rules adopted by the Department of Transportation pursuant to G.S. 136-18."

(Note: Only the sections pertaining to elections have been set out herein. The majority of the bill deals with increased criminal penalties for littering.)

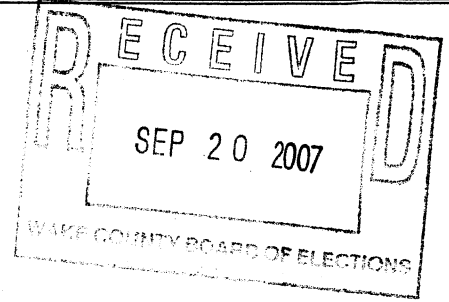

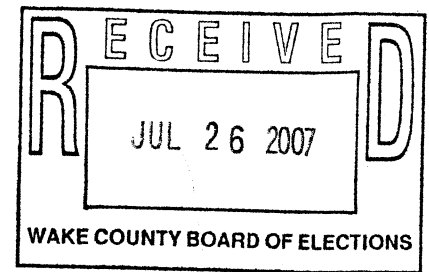
