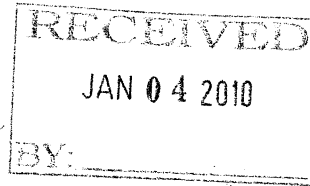

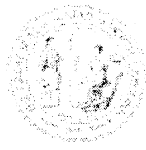
We took in no money and spent no money, either through any childrens PAC account or through personal accounts.

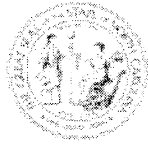

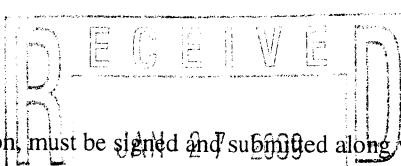
