1	S	Researches files, records, plats and historical documents for legal descriptions, addressing information and ownership information. Reads and interprets deeds and plats. Updates corresponding information by entering data and mapping new information. Makes necessary map changes and updates and forwards information to the appropriate agency. Coordinates source documents to distribute to mapping team to create new parcels and modify and reconcile existing parcels. Assists staff in investigating and resolving mapping issues.
2	S	Coordinates related activities with internal departments and external municipalities. Participate in multi department projects to analyze users' needs, improve data system integration and improve efficiencies involving work processes among departments.
3	L	Assists customers with questions, conducts demonstrations on software and system functionality.
4	S	Evaluates and recommends software, coordinates information needs and assists with user training.
