BRIEF DESCRIPTION: Conducts comprehensive assessments and provides direct patient care as required. Addresses needs and coordinates care with other community providers as warranted. Conducts psychological tests.

2	S	Develops and leads psycho-educational groups to educate and assist clients. Leads therapy groups oriented toward providing interventions and support for clients to meet established treatment goals.
3	S	Provides education and training for staff, families and the community. Distributes information and facilitates programs involving outside speakers.
4	S	Documents client and family contact, completes appropriate forms and discusses at peer review meetings. Determines possible support from ancillary agencies.
