**BRIEF DESCRIPTION:** Ensures the quality and accuracy of all criminal fingerprint cards. Examines cards and enters appropriate information into databases. Disseminates information to other law enforcement and regulatory agencies and testifies in the courtroom.

#	Code	Essential Functions
1	S	Reviews all fingerprint cards to ensure all prints are clear, classifiable, placed in the appropriate blocks and ready for acceptance into databases. Maintains logs of all work performed.
2	L	Reviews all data and electronically transfers fingerprint images and associated data into fingerprint identification systems to create criminal histories.
3	L	Determines if arrestees are repeat offenders. Verifies identities by placing thumbs on fingerprint instruments and transmitting images. If verified, an additional thumbprint is verified and video images are captured and saved.
4	S	Testifies as an expert witness and assists other law enforcement agencies in identifications. Disseminates authorized information and photographs to outside authorized agencies.
5	S	Develops and presents training to new employees on methods of identification and verification.
